However, in case the date of opening is declared a Government Holiday, the tenders will be opened on following working day at scheduled time <u>11.00 AM</u>.
- 2. The quotations shall be submitted according to the terms and conditions specified in paragraphs **3 to 24**. Unless specified otherwise in the quotation, it shall be construed that the terms and conditions stipulated hereunder have been agreed to.
- 3. The rates should be F.O.R. (if applicable) and should include (if applicable) transportation cost, excise duty, freight any other rates or imposition whatever liable in respect of the supplies freight etc. GST / Sate Tax at specified rates must be expressly stipulated in the quotation.
